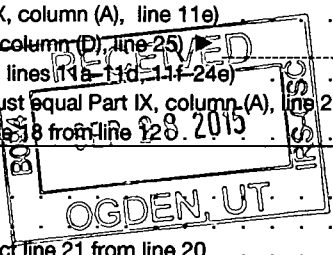

Peru Volunteer Program. In 2014, 109 young people participated in our volunteer program, which is oriented towards fostering understanding of Peruvian culture as well as professional development in the areas of medicine, music, education and engineering. We executed 8 medical campaigns serving 875 patients and invested more than 15,630 volunteer hours and \$11,100 in material donations and community outreach to promote development in Peru. Volunteers also participated in health prevention and education workshops reaching 450 community members as well as Christmas events where toys were distributed to children in the community. Volunteers also traveled to Cusco and visit Machu Picchu to learn about the roots of the Incan culture and appreciate the rich history of Peru.
