The trust provides that the assets of the trust are to be held in trust by the trustee for the use and benefit of the University of Illinois Foundation in providing scholarships at the University of Illinois, Urbana, Illinois. Distributions from the trust are to be used solely for the education and maintenance of students at the University of Illinois who meet certain conditions provided in the trust and whose parents are financially unable to provide for their college education.

Pt III, ln 4a EXEMPT PURPOSE ACHIEVEMENT: For the fiscal year ended January 31, 2015, the Trust will have distributed \$422,149.71 to the University of Illinois Foundation for providing scholarships. While the final numbers for the 2014-2015 school year are not yet available, prior years indicate that in any one school year, as many as 163 students received scholarships as a result of this Trust's support.

Pt VI-A, ln 1a GOVERNING BODY: The organization is a charitable trust; as such, it does not have any voting members. It is directed and managed by an independent corporate trustee, Busey Trust Company.

Pt VI-B, ln 11b REVIEW PROCESS FORM 990: Busey Trust Company, as trustee, retains an outside public accounting firm to prepare its Form 990 and related attachments. The accounting firm provides a draft of the return to the Trust Company employee responsible for signing the return. Her comments and changes are then incorporated in the return and the return is otherwise finalized. A copy of the Form 990 is provided annually to the University of Illinois, the supported organization.

Pt VI-B, ln 12c POLICIES: The organization is a charitable trust. Its trustee is Busey Trust Company. Busey Trust Company, as a separate organization, does have a written conflict of interest policy. Its officers, directors and employees are required to disclose annually interests that could give rise to conflicts. The Busey Trust Company regularly and consistently monitors and enforces compliance with this policy through employee education and representation.
