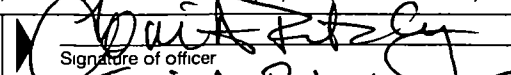

Transportation Project: Raised funds and provided necessary transportation for middle & high school therapeutic program students for necessary medical appointments and also for attendance at various events, including but not limited to sporting events, community service project works, performing arts events and other recreational and therapeutic events.
Through this program we were able to provide annual transportation services for over 18,000 teens and support staff.

4b (Code:) (Expenses \$ 65,000 including grants of \$) (Revenue \$)
Program Development: One of the goals of the foundation is to investigate and develop alternative therapeutic programs. This program involved the development of a skatepark that is used specifically to treat teens and young adults who need intensive therapy for emotional and behavioral issues. This is based off a program that was recently developed for veterans and returning military for treatment of PTSD related issues. The need for this type of program stems from the highly addictive/adrenaline focused psyche of this target population. The skatepark is located in Southern Utah where the majority of youth residential treatment facilities are located. The skatepark opened in July 2014, and is used daily by approximately 5-8 at-risk teens and their therapists, and is open for others. This fiscal year, approximately 1,250 teens have benefitted.

4c (Code:) (Expenses \$ 48,928 including grants of \$ 9,438) (Revenue \$)
Teen & Family Empowerment Events: One of the major program goals is to provide empowerment type activities for teens and parents, these include game nights, sports events, animal interactions, outdoor activities (ziplines, obstacle courses, adaptive sporting activities), art activities, workshops and motivational speakers. This year we provided 67 different events which served over 1,875 participants.
