In FYE 2015, six (6) support groups were organized and held a total of 65 meetings throughout the year. 324 attendees (including ALS patients, caregivers and family members) attended. The Organization also offers a medical equipment loan program through which patients may receive items not covered by insurance, such as power wheelchairs, communication devices or shower chairs, etc. Assistive medical equipment and communication devices are items that increase patient mobility and help them maintain a degree of independence as they lose muscle control. 85 ALS patients received loaned equipment in FYE 2015 (15 of those 85 received loaned communication devices). The Organization delivers equipment to ALS patients and provides training for families. In addition to offering one-on-one patient consultation and medical equipment, the ALS Association of Georgia Patient Services Program provides: *Assistive Technology Program to customize communication devices and train patients and their caregivers on its proper use, *Respite Care to relieve stress and "caregiver burnout", *Support Groups for patients, family members, caregivers and friends, *Access to ALS Clinics staffed by neurologists, speech and respiratory therapists, social workers and dietitians, *Annual Educational Symposium designed to educate on current medical and psychosocial clinical care standards in ALS, *Hope for tomorrow through ALS Association funded research at Emory University and across the nation
