The Shop With the Sheriff and Fourth Street Corridor programs for indigent children are supervised by volunteers from the Honorary Association and Washoe County Sheriff's Office employees. The programs support indigent children and their families who are nominated by various local public and charitable organizations as qualifying for federal assistance. No public grant funds are obtained or distributed by the Honorary Association. All dues/donations/grants are reported to the membership with the membership providing input in regard to potential projects to support. Individuals receiving training are typically scheduled to appear before the Association members to relate their experiences at the training facility with live demonstrations by the K-9 dogs and static displays of new equipment conducted at meetings of the Association.
