


THE FEES FROM PLATE PURCHASES AND RENEWALS GO TO TAHOE'S PUBLIC ENVIRONMENTAL AGENCIES, THE CALIFORNIA TAHOE CONSERVANCY AND THE NEVADA DIVISION OF STATE LANDS, TO FUND HIKING AND BIKING TRAILS AND WATERSHED RESTORATION.
