KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this 13th day of October, 1994, voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Connecticut, and we hereby certify:

FIRST: That the name of said non-profit corporation shall be "Danbury Lodge, No. 120, of the Benevolent and Protective Order of Elks of the United States of America."

SECOND: That the purposes for which said Corporation is formed are:

- (a) The primary purpose for which this Corporation is formed is to inculcate the principles of Charity, Justice, Brotherly Love and Fidelity; to promote the welfare and enhance the happiness of its members; to quicken the spirit of American patriotism; to cultivate good fellowship and to perpetuate itself as a fraternal organization.
- (b) Other purposes for which this Corporation is formed are: to do all the acts and things, and business and businesses in any manner connected with the objects or purposes or powers of the corporation, or necessary, incidental, convenient or auxiliary thereto, calculated directly or indirectly to promote the interests, objectives, and ideals of the organization, and in addition, to have and exercise all rights, powers and privileges now or hereafter belonging to or conferred upon non-profit corporations existing under the laws of the State of Connecticut.
- (c) The foregoing statement of purpose or purposes shall be construed as a statement of both purpose and powers and the purposes and powers in each clause shall, except where otherwise expressed, be in nowise limited or restricted by reference to or inference from the terms of provisions of any other clause, but shall be regarded as independent purposes and powers.
