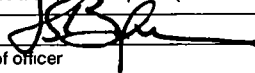

During 2014 the Institute, in support of its commitment to provide regional access to high performance computing (HPC) systems and services, invested in additional hardware resources, purchased software application licenses, and technical staff resources to support secure access by public and private organizations, including academic, commercial and governmental agencies. Resources acquired and deployed were for the specific purpose of supporting users in their efforts at using modeling, simulation, visualization and data analytics in the design of experiments and manufactured products.

4b (Code:) (Expenses \$ 83,552 including grants of \$) (Revenue \$)
The Institute's mission includes acting as a convener of regional discussions on topics ranging from computational science and technology, grand challenge problems requiring collaboration among multiple organizations, and development of an entrepreneurial community supportive of incubators and accelerators focused on new business development. In this capacity the Institute engaged in mentoring activities and applied computational science research, focused primarily in the advanced manufacturing and water resources domains.

4c (Code:) (Expenses \$ 84,272 including grants of \$) (Revenue \$)
The Institute remains committed to being a regional and statewide resource to business and government focused on the development of policy and shared "cyber" infrastructure. This work is carried out through the Institute's active membership in 1) WTC (the Wisconsin Technology Council, advisors to the Governor and Legislature), 2) MWERC (the Midwest Energy Research Consortium), 3) GWC (the Global Water Council), 4) BioForward (bioscience and pharmaceutical consortium), 5) FaB (the Food and Beverage Consortium), and a number of Wisconsin economic development agencies, including the Wisconsin Economic Development Corporation.
