	Surfing Heritage has a temporary exhibition area where we rotate 4 different exhibits related to surf culture every year. As Surfing Heritage has members that receive free admission and is open to the public, we like to keep the interest of our followers by changing the rotating surf culture exhibit quarterly. Our public outreach included several events such as book signings, lectures, and movie premieres. The famed Endless Summer Collection was acquired by SHACC and put on exhibit at Surf Expo, Orlando, FL, and also at SHACC major fundraiser celebrating the 50th anniversary of the iconic surfing film and most watched documentary film of all-time, The Endless Summer, on May 3, 2014. We continue our efforts to build and maintain an archive of the history of the sport and culture of wave riding as recorded by photography and oral histories. Surfing Heritage provides hosted and individual tours of extensive historic surfboard archive and photo collection to students and surfing enthusiasts. This committee develops curriculum for the educational community in California and beyond. Surfing Heritage is becoming the "go to resource" by other museums and institutions when looking for photos, surfboards and other historic surf culture items for their own exhibits. We are curating a collection of historic surfboards that will be inducted into the Smithsonian Museum later this year along with items associated with the Endless Summer. Surfing Heritage uses new social and business media as part of its outreach program. Last year we had over 90,000 visits to our website, over 1,300 followers on Twitter, Facebook page reaches nearly 7,000 per month, surf channel has close to 5,000 viewers per month. Our monthly e-newsletter is received by more than 9,000 people.
