Medical Services:

We had more than 2,800 contacts with clients in 2014. All services were free with the exception of a nominal fee for STD tests. These services included counseling women in crisis pregnancy situations, providing more than 1,100 pregnancy tests, performing 246 ultrasounds (172 lives were saved from abortion), providing pre-natal care instructions to expectant mothers, and performing testing for sexually transmitted diseases.

Abstinence Education:

Our abstinence education curriculum, Willing to Wait, was taught in 68 schools to more than 6,000 students during the 2014-2015 school year. More than 4,000 students pledged abstinence until marriage. In addition, we presented the abstinence message to many local churches and community members.

Family Support Services:

We had more than 3,500 contacts with clients in 2014. These services included counseling mothers and providing more than 140,000 material items to the economically disadvantaged including diapers, formula, cribs, baby clothing, maternity clothing, etc.
