With an initial investment of \$500,000 from The Kresge Foundation in early 2010, CMF launched the Community Foundation Challenge Grant to encourage Michigan community foundations to expand, enhance, strengthen and sustain their local college access partnerships. CMF believes that community foundations are ideal candidates to support local college access programs because of their long-standing support of college scholarships, their leadership and commitment to MCAN efforts, and their position as vital leaders in Michigan's communities. The purpose of the Community Foundation Challenge Grant initiative is to leverage local private investment to engage and sustain college access partnerships, thereby increasing the college-going rate and culture in Michigan.

CMF has two offices that work directly with the Governor of Michigan. The Office of Foundation Liaison was established in 2003 to manage strategic partnerships between foundations and state government to improve the lives of Michigan citizens. Funded by foundations the offices of three staff is located in Lansing with direct access to the Governor. The Office of Urban & Metropolitan Initiatives is focused on economic impact and job growth initiatives respective to urban and metropolitan areas. This office includes a staff of five located in key areas around the state. Support for this office comes from both foundations and the business community.

As a membership association of foundations & corporate giving programs CMF provides resources to members through its website, seminars, conferences and publications.
