**Legislative**

After an effort spanning two legislative session, our work to coordinate a grass roots lobbying campaign to increase the minimum wage in Minnesota resulted in success as the legislature raised the minimum wage for the first time in 9 years. The legislature also acted on another one of our priorities when they passed the Women's Economic Security Act (WESA). We also worked in coalition with a number of private and public entities (MOVE Minnesota) in an effort to significantly increase transportation funding in Minnesota. After the 2014 elections sent a Republican majority to the State House of Representatives, our work shifted to (successfully) preserving the gains we had made in the previous session of the Legislature.

**Political**

Considerable effort was put into educating and mobilizing the members of our affiliated unions to support our endorsed candidates in the 2014 elections. Using a grant from the National AFL-CIO we established a Path to Power program which hosted a number of trainings around the state for union members interested in someday running for political office.

**Organizing**

We hired a Strategic Organizing Director and a Strategic Organizing Research Director to assist our affiliates in their organizing efforts. We were also able to kick off an industrial apprenticeship program to help train the workers needed to fuel our manufacturing and industrial sectors. Also new is a program to provide mentorships to women entering the building and construction trades.

**Convention**

We hosted our Constitutional Convention in September. Delegates voted on political candidate endorsements, passed resolutions to guide the work of the Minnesota AFL-CIO and elected (or reelected) the officers, executive board and general board of the Federation.

**State Fair**

We coordinated the planning and activities of our affiliates at the Minnesota AFL-CIO Labor Pavilion at the Minnesota State Fair.

**Communication**

In addition to the ongoing work of the Communications staff – the weekly email *Labor Update*, press releases and interviews etc. - we started a podcast, *Minnesota Works*.
