Consequently the deficit doesn't represent the actual net revenue/loss for the fiscal year.
Other	Pt I, line 6d - More often than not, there is a loss on line 6d since the fair market value of tickets and other event revenue (raffles, etc.) is less than the direct costs. Expenses for postage and printing of invitations, program printing, and other costs are not part of the FMV of the ticket price so become expenses not offset by revenue on line 6b.
