Children and Youth Programs

ServeNow works with disadvantaged children and orphans, as well as street children, in centers located in some of the major slums in India. In some locations schools from Kindergarten to Grade 4 are in operation, in other areas children are taught to read and write, as well as taught life values through teaching, drama and music. Through special summer programs the children are taught lessons from the Bible. ServeNow also works with children in Ukraine, Nepal and Uganda, through training programs, summer camps and school education.

Scripture and Church Teaching

One of the major projects of ServeNow is to assist local congregations in remote areas and in the slums, providing such churches with basic Scriptures. Pastors are also trained in major themes of church teaching. ServeNow provides training materials for each member in these congregations on a long term basis. Individual training programs are also conducted in strategic locations in each country.

Humanitarian Programs including containers

In areas where it gets freezing cold and children and elderly have no winter coverings, we provide winter clothing (currently to approximately 4,000 people). In remote villages and in slums ServeNow provides one day medical camps, with national physicians and nurses, seeing approximately 150 patients a day. These camps take place almost every week in a different location. In the summer when drinking water is scarce, such is provided for a month for individual families. To train young women in a trade, to prevent them from being drawn into trafficking, ServeNow operated several tailoring schools as well as cosmetology schools and handicraft schools. ServeNow also provides container loads of humanitarian aid such as medical equipment, clothing and furniture to the war-torn areas of Ukraine and in Uganda.

"Serving people in need by caring for orphans, widows, underprivileged children and youth by providing humanitarian assistance where

needed." The Salvation Army Humanitarian aid receives medical, handicap, and personal equipment from hospitals, community centres and

companies. We have written agreements with counties, commmunities and private companies regarding their equipment. When we receive

different items, the hospital establishes the price for each piece of equipment. Depending on its prior use, we discount those prices up to

40%. There are stringent rules regarding comfort, standard and durability, both from EU and Swedish authorities. All items received and then

passed on to ServeNow are cleaned, renovated and in full working condition. Medical machines, etc., are checked by technicians from the

donating hospital. As an extra control, we value each major piece of equipment, with matching age, from other groups like EBay.
