Position comparability data supplied to them by the Director of Human Resources and Administration is reviewed. The data is taken from independent national compensation and industry surveys.

NMPP has a profit sharing program which covers all full-time and regular part-time employees, except the Executive Director. Any profit sharing contribution is based on the audited net revenues (ie net income) of the combined net revenues of the NMPP coalition of companies in excess of budgeted net revenues, as approved by the individual Boards of Directors of the respective companies for the fiscal year. Any bonus paid to the Executive Director is determined annually by officers of NMPP and the officers of the other three coalition entities, for which the NMPP Executive Director also serves as Executive Director. No payments or accruals were made under the terms of the profit sharing program for the year reported.

sharing facilities and personnel. The allocation of staff compensation is based on estimated time incurred by each staff member in the

support of the activities of each entity. This allocation is reviewed and approved annually by Board representatives from each of the entities.

NMPP is reimbursed from the other coalition members as payroll expense is incurred. None of the full-time employees of NMPP have 100%

of their time allocated to NMPP operations.
