FLORIDA CITRUS SPORTS EVENTS (FCSE) PROVIDES THE MANAGEMENT AND ADMINISTRATIVE SUPPORT FOR THE ANNUAL RUSSELL ATHLETIC AND BUFFALO WILD WINGS CITRUS BOWL GAMES, WHICH ARE HOSTED BY THE RELATED TAX-EXEMPT ORGANIZATIONS TANGERINE SPORTS ASSOCIATION AND FLORIDA CITRUS SPORTS ASSOCIATION , AND THE FLORIDA CLASSIC (HBCU COLLEGE FOOTBALL) THESE EVENTS PROVIDE NATIONAL EXPOSURE TO THE CENTRAL FLORIDA COMMUNITY, WHILE GENERATING OVER \$71 MILLION OF ECONOMIC IMPACT FOR THE REGION.
