In evaluating the collectability of patient accounts receivable, the Company analyzes its past history and identifies trends for each of its major payor sources of revenue to estimate the appropriate allowances for both contractual adjustments and the provision for bad debts. For uninsured patients only the amounts that would normally be paid by insurance companies are considered bad debt (ie bad debt is not calculated on gross charges but rather on average realizable commercial rates).

In order to calculate the estimate of bad debt expense attributable to charity care the Company reviewed household income statistics from the 2007-2012 American Community Survey for all cities within a 10 mile radius of the hospital campus and calculated the number of household that would qualify for charity care based on a 200% of the Federal Poverty Limit threshold.

The calculated amount was not included in the community benefit summary above as the Company requires a successfully completed charity care application for an account to be included in the charity care at cost line above.

The Company's patient accounts receivable are reduced by allowances for contractual adjustments and doubtful accounts. In evaluating the collectability of patient accounts receivable, the Company analyzes its past history and identifies trends for each of its major payor sources of revenue to estimate the appropriate allowances for both contractual adjustments, and doubtful accounts and provision for bad debts. Management regularly reviews data about these major payor sources of revenue in evaluating the sufficiency of these allowances. The difference between the standard rates (or the discounted rates if negotiated) and the amounts actually collected after all reasonable collection efforts have been exhausted is charged off against the allowance for doubtful accounts.

The Company's allowance for doubtful accounts increased from 8.0 percent of gross patient accounts receivable at March 31, 2014 to 14.1 percent of gross patient accounts receivable at March 31, 2015. In addition, the Company's write-offs were approximately \$438,000 and \$864,000 for the years ended March 31, 2015 and 2014, respectively. The Company has not changed its charity care or uninsured discount policies during 2015 or 2014.

The Community That Casa Colina Serves

The Casa Colina Hospital service area population includes 20 ZIP Codes, 12 cities or communities, one Service Planning Area (SPA) within Los Angeles County. In addition, there are 6 ZIP Codes and three cities located in San Bernardino County.

In 2014, there were 1,128,613 people living in the Casa Colina Hospital service area which is a 2.1% increase from 2010 (n=1,105,815); a similar increase was seen in Los Angeles County (2.5%) and an even larger increase in San Bernardino County (3.5%).

In 2019, the population is expected to grow 3.1% from the 2014 population count (1,125,613 to 1,163,134). A similar increase is expected for Los Angeles County (3.4%) and an even larger increase is expected in San Bernardino County (4.5%)

Ethnically, the population in the Casa Colina Hospital service area is mostly composed of Hispanic/Latino (49.0%) residents followed by White/Caucasian (28.3%). The same is true for Los Angeles and San Bernardino Counties where large percentages of its residents are Hispanic/Latino (50.0% and 52.7%, respectively) and White/Caucasian (26.6% and 29.5%, respectively).
