

In FY 2014 PCs for People collected almost 10,000 computers and laptops. Over the course of the year these PCs were refurbished and distributed to low income families. A total of almost 8,000 PCs were distributed. PCs for People also supports the computers distributed with a 90 day warranty and does discounted repairs after the warranty period. Repairs are \$25 and any parts needed are free. In FY 2014 over 2,500 repairs were completed at an average cost of \$20 per repair.
