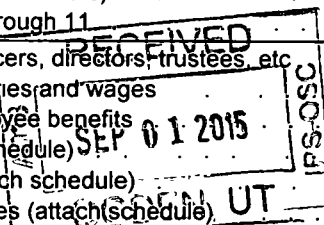

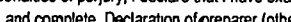

BY-LAWS
of
WALGREEN BENEFIT FUND
(Amended and Restated December 1, 2014)

ARTICLE I
Name, Office and Purpose

The name of the "Corporation" is the Walgreen Benefit Fund, and the Corporation shall maintain a registered office within the State of Illinois and a registered agent at such office. The Corporation may establish and maintain such additional office or offices, within or without the State of Illinois, as the Board of Directors may authorize.

The purposes for which the Corporation is organized are as follows:

The corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Code). The primary purpose of the corporation is to provide monthly or lump-sum relief award payments to certain employees and retirees of the Walgreens family of companies who are in extreme financial need and are facing unusual, sudden or severe financial hardship.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of the Articles of Incorporation, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE II
Membership

Section 1 The membership of this Corporation shall be constituted as follows:

(a) All persons who, at the time of the adoption of these Amended and Restated By-Laws, shall be members of the Corporation.

(b) The Membership Committee, by unanimous vote, may elect to membership any employee of Walgreen Co. (an Illinois corporation), or of any of its subsidiaries or affiliates, who shall be in sympathy with the objects and purposes of this Corporation and shall give evidence of a willingness to work toward their accomplishment.

Section 2 Memberships shall not be transferable. The membership of any member shall cease upon his resignation; or upon termination, for any reason whatsoever, of his employment by Walgreen Co. or its subsidiaries or affiliates; or if, upon a majority vote of the Board of Directors, he shall be found to be unqualified for membership under Section 1(b) of Article II of these By-Laws.

Section 3. No membership certificates shall be issued to the members, and no person shall be deemed to be a member of the Corporation unless his name shall appear as such upon the roster of the Secretary of the Corporation, which shall constitute the sole and conclusive evidence of membership in the Corporation.

ARTICLE III Meetings of Members

Section 1. Meetings of the members shall be held at the principal office of the Corporation, in Deerfield, Illinois, or at such other place within the State of Illinois as the Board of Directors may designate 5/27/76

Section 2 All persons who shall be members of the Corporation on a date ten (10) days prior to the date fixed for the holding of any meeting shall be entitled to notice of the time, place, and purpose of such meeting, and to be present and vote thereat, in person only and not by proxy. Notice of all meetings of the members shall be provided to each member entitled thereto not less than ten (10) days prior to the respective dates of such meetings, unless such notice is waived. 12/1/14

Section 3. The annual meeting of the members shall be held by August 31 of each year At such meeting (or, if the annual meeting be not held, then at any special meeting called for that purpose), members shall, by a plurality vote by ballot, elect directors to serve for the ensuing year. The President shall submit a full report of the Corporation's activities during the fiscal year next preceding the meeting; and the Treasurer shall submit a report of all receipts and disbursements and a statement of the financial condition of the Corporation Such other business may be transacted as shall properly come before the meeting 6/6/02

Section 4 Special meetings of the members may be called by the President or the Board of Directors and shall be called upon the written request of not less than one-third (1/3) of the members, submitted to the President.

Section 5 A majority of the members of the Corporation, present in person, shall constitute a quorum for the transaction of business; and except as herein otherwise provided, a majority vote of the members present at any meeting of the members at which a quorum shall be present shall be sufficient to carry any measure submitted to vote at such meeting 12/1/14

ARTICLE IV Board of Directors

Section 1. The business and affairs of the Corporation shall be managed by a Board of Directors consisting of a minimum of five (5) and a maximum of fifteen (15) members, who shall be chosen from the membership of the Corporation by a plurality vote. Directors shall be elected annually, at the annual meeting of the members or at any special meeting called for the purpose of holding such election, to serve until the next annual meeting and until their respective successors shall have been elected and shall have qualified. 6/26/89

Section 2. In case of a Director's refusal, inability, or neglect to perform the duties of his office, the Board of Directors may, by the unanimous vote of all other Directors, remove such Director. 12/1/14

Section 3. Any vacancy occurring on the Board of Directors by reason of the death, resignation, or removal of any Director, or by reason of an increase in the number of Directors, may be filled for the unexpired term by the remaining Directors.

ARTICLE V

Meetings of the Board of Directors

Section 1. The annual meeting of the Board of Directors, at which the Officers of the Corporation shall be elected and such other business shall be transacted as may properly come before the meeting, shall be held at the same place as and immediately following the annual meeting of the members. No notice of such meeting shall be required. Other regular meetings may be held at such place and at such intervals as may be determined upon by the Board of Directors. Special meetings shall be held whenever the same may be called by the President or Vice President or by any two Directors, at such time and place and for such purposes as may be stated in the notice thereof.

Section 2. Three days' notice of all meetings of the Board of Directors (other than annual meetings), stating the time, place, and purpose thereof, shall be given to each Director (unless such notice shall be waived), except that meetings at which all of the Directors shall be present may be held at any time and place, and for any purpose permitted by the By-Laws, without notice. 12/1/14

Section 3. A majority of the Board of Directors shall constitute a quorum for the transaction of business; and except as herein otherwise provided, a majority vote of the Directors present at any meeting of the Board of Directors at which a quorum shall be present shall be sufficient to carry any measure submitted to vote at such meeting.

Section 4. Any action required to be taken at a meeting of the Board of Directors, or any other action which may be taken at a meeting of Directors, may be taken without a meeting if a consent in writing, setting forth the action so taken, shall be signed by all the Directors entitled to vote with respect to the subject matter thereof. 12/1/14

ARTICLE VI

Officers

Section 1. The Officers of the Corporation shall be a President, one or more Vice Presidents, Secretary, and Treasurer, who shall be elected by the Board of Directors, from the membership of the Corporation, at annual meetings, or, if an annual meeting of the Board of Directors be not held, then at any special meeting called for the purpose of holding such election. Officers shall hold office until the next annual meeting and until their respective successors shall have been elected and shall have qualified. 12/1/14

Section 2. The President shall be the principal Executive Officer of the Corporation and shall in general supervise and control all of the business and affairs of the Corporation. It shall be his duty to preside at all meetings of the members and of the Board of Directors. The President shall be ex-officio member of all committees. 12/1/14

Section 3. In the absence or inability of the President to act, any Vice President may execute any of the powers or duties of the President.

Section 4. It shall be the duty of the Secretary to attend to the correspondence of the Corporation (including the giving of notices as herein provided), to keep a roster of the members of the Corporation, and to keep or cause to be kept the minutes of the meetings of the Board of Directors and members, in books which shall be the property of the Corporation and open to inspection by members of the Board of Directors at the principal office of the Corporation at all reasonable times. He shall sign, with the President or Vice President, all documents requiring such signature, when duly authorized by the Board of Directors

Section 5. It shall be the duty of the Treasurer to receive funds of the Corporation, and to disburse such funds only upon order of the Board of Directors or upon order of such committee or officer as may be thereunto duly authorized by the Board of Directors. The Treasurer shall keep full and accurate books of account which shall be open to inspection by any member of the Board of Directors at the Corporation's principal office at all reasonable times. The Treasurer shall, upon request, render reports or financial accountings to the Board of Directors, and shall, at each annual meeting of the members of the Corporation, render a report showing receipts and disbursements for the fiscal year. 12/1/14

The Treasurer shall give a bond for the faithful discharge of his duties, in such sum as the Board of Directors may require. 12/1/14

Section 6 The Officers of this Corporation shall have such further powers and duties, not inconsistent with these By-Laws, as are commonly incidental to their respective offices, or as may be delegated to them by the Board of Directors

Section 7 The Board of Directors may elect one or more additional Vice Presidents, an Assistant Secretary, and an Assistant Treasurer, or any of them, charged with such duties and clothed with such powers as the Board of Directors may prescribe

Section 8. Any Officer may be removed from office at any time at the pleasure of the Board of Directors

Section 9 If an office shall become vacant due to the death, resignation, or removal of any Officer, the Board of Directors shall fill such vacancy by the election of a successor to serve for the unexpired term.

ARTICLE VII Committees

Section 1. The Board of Directors may designate one or more committees, each committee to consist of at least two directors of the Corporation. The Board of Directors may designate one or more directors as alternate members of any committee, who may replace any absent or disqualified member at any meeting of the committee. In the absence or disqualification of a member of the committee, the member or members present at any meeting and not disqualified from voting, whether or not such member or members constitute a quorum, may unanimously appoint another member of the Board of Directors to act at the meeting in place of any such absent or disqualified member. Any such committee, to the extent permitted by law and provided in these Bylaws or in the resolution of the Board of Directors, shall have and may exercise all the powers and authority of the Board of Directors in the management of the business and affairs of the Corporation. 12/1/14

Section 2. Unless the Board of Directors otherwise provides, each committee designated by the Board of Directors may make, alter and repeal rules for the conduct of its business. In the absence of such rules each committee shall conduct its business in the same manner as the Board of Directors conducts its business pursuant to Article V of these Bylaws. 12/1/14

Section 3. The Membership Committee shall receive and pass upon all applications for membership in the Corporation. No person shall be elected to membership except by the unanimous vote of the Membership Committee.

ARTICLE VIII Compensation and Indemnification

Section 1. The officers and directors shall receive no compensation for their services as such officers and directors, but any employee of the Corporation may be compensated, at reasonable and usual rates, for services provided to the Corporation.

The Corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (a "proceeding"), other than a proceeding by or in the right of the Corporation, by reason of the fact that the person is or was a director, officer, employee or agent of the Corporation, against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by the person in connection with the defense of such proceeding if the person acted in good faith and in a manner the person reasonably believed to be in or not opposed to the best interests of the Corporation, and, with respect to any criminal action or proceeding, had no reasonable cause to believe their conduct was unlawful

Section 3. The Corporation shall pay or reimburse the reasonable expenses incurred in defending any proceeding in advance of its final disposition if the Corporation has received an undertaking by the person receiving such payment or reimbursement satisfactory to the Corporation, which may require that such undertaking include a bond, security interest, or other security for such undertaking, by or on behalf of such person to repay all amounts advanced if it should be ultimately determined that he or she is not entitled to be indemnified under this Article VIII or otherwise

ARTICLE IX Contracts, Checks, Deposits and Funds

Section 1. The Board of Directors may authorize any officer or officers or agent or agents of the Corporation to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Corporation and such authority may be general or confined to specific instances.

Section 2. The current funds of the Corporation shall be deposited in such bank or banks as the Board of Directors may from time to time select, and shall be drawn out only upon checks or drafts signed as authorized by the Board of Directors

Section 3. The funds of the Corporation shall be used for the following purposes only:

- (a) For current expenses of the Corporation or ordinary and necessary expenses incurred in connection with programs for the raising of funds;
- (b) To pay debts of the Corporation;
- (c) For religious, charitable, scientific, literary, or educational purposes; by either promoting, establishing, conducting and maintaining activities on behalf of this Corporation, or by contributing to or otherwise assisting other corporations, organizations, and institutions carrying on such activities; and

- (d) To invest in such securities and other assets as the Board of Directors, or a designed committee thereof, shall select.

ARTICLE X Fiscal Year

The Corporation's books of account shall be kept on the basis of a fiscal year ending on April 30 of each year

ARTICLE XI Corporate Seal

The corporation may, but need not, adopt a corporate seal. Any corporate seal adopted by the corporation shall have the name of the corporation inscribed thereon and shall be in such form as may be approved from time to time by the Board of Directors. The failure to use such seal, however, shall not affect the validity of any documents executed on behalf of the corporation.
