Annual Convention & Clinics: The ABCA Convention is the world's largest baseball coaching clinic. The convention clinics promote education and training in coaching, leadership, sportsmanship, and ethics with 3,143 coaches attending in 2015, out of 5,670 active coaches for the fiscal year ending 4/30/15, during which 30 well-known clinic speakers provided presentations to the attendees for three days. The ABCA sponsors youth clinics at the NCAA, NAIA, and junior college world series, involving several hundred young people each. The ABCA also provides a grant to International Sports Group, which conducts educational coaching clinics around the world. ABCA member coaches and ABCA staff collaborate to advance amateur baseball through promotion of the game, education and advocacy.

Awards Programs: ABCA awards to members include the Hall of Fame, Lefty Gomez Award, Ethics in Coaching Award, Honor Awards, Meritorious Service Awards, Assistant Baseball Coach of the Year Award, Field Maintenance Award and Field Scholarship Award, Century Club Awards, 25-year Coaching Awards, and Lifetime Membership Awards. Award programs to serve amateur baseball include selection of the national player of the year, All-America, All-Region and Gold Glove Teams from each division: NCAA I, II, and III, NAIA, NJCAA, Pacific Association Division and high school, as well as regional and national coaches of the year from each of the aforementioned divisions.

Publications, Websites & Educational Materials: "Covering All Bases" is a tri-annual newsletter is mailed to members, keeping them informed of baseball news, as well as on the ABCA website, including NCAA, NAIA, Junior College, and high school legislation; federal and state governmental issues; college/pro issues; conference, and school issues. The ABCA primary website (www.abca.org) is a helpful, informative tool to coaches. From 5/1/14 to 4/30/15, the ABCA received 1,925,064 page views for an average of 160,422 page views per month. The website contains information about clinic videos, ABCA/Human Kinetics books and videos, and other coaching resources. Other information available on the ABCA website includes: convention and membership registration; job postings; scheduling; information on all
