Provide scholarships to college bound high school seniors and stipends for two student tutors/mentors. Each year, Bucks County high school seniors are invited to apply for the Link Scholars, a \$2,000 renewable scholarship for four years. A selection committee reviews the applications for academic success, community service leadership. In the current program year, the chapter provided scholarships ranging between \$1,000 - \$2,000 to five Bucks County students attending colleges in the United States. The chapter also supports high school students at Kuntu Village in Ghana, West Africa by funding tuition/boarding fees in the amount of \$450 per student and a tutor/mentor program for other students. Kuntu Village is a small, impoverished village with an unemployment and literacy rate of approximately 90%. The Bucks County Chapter partners with Kuntu Village Nkosohen Committee - USA to provide tuition support, school supplies and curriculum development.

Annual Health fair with dental screening services for uninsured children. The Bucks County Chapter has established a partnership with Colgate-Palmolive Company's "Bright Smiles, Bright Futures" program which is focused on increasing awareness of children's oral health. Each year, the chapter hosts a health fair in Bucks County, PA to provide information, resources, and screening opportunities that will ultimately decrease the risk of dental cavities and periodontal diseases in underserved communities. Approximately 200 visitors stops by the informatin booths an receive literature from various health service providers. At least 80 children received dental screenings.

"Smart in the Arts" program that seeks to expose youth living in economically disadvantaged communities to arts and cultural programs that builds their self esteem and provides tools for success; an annual Poster Arts contest for K-12 students of the Morrisville School District; and supplies, clothing or other humanitarian aid for families in need.
