Organization promotes and develops the art of ballet and dance, providing conservatory training without any commercial trappings. Our programming ensures that families can afford the cultural enrichment for children. The organization also provides several fully staged professional ballet productions annually, all subsidized for the public in a community traditionally underserved in the ballet arts. Significant levels of free training and free tickets are also awarded to economically challenged homes and groups.

The organization provides up to eight ballet productions annually, including the New York Choreographers Festival, and a fully staged 3-act Nutcracker using acclaimed guest artists and Broadway sets. The events engage New York's talent pool of artists, performers, musicians and theater crafts professionals, providing a vibrant venue for dance on Staten Island, which is still recovering from multi-billion-dollar losses in deadly Hurricane Sandy 3 years ago. Free tickets are given to other not-for-profits and financially challenged homes. Our dancing Over Walls program gives free, unlimited dance classes to youths in need. Our Children and Seniors Together (C.A.S.T.) program is an inter-generational program helping both youths and seniors explore their mutual realms in free special performances. About one-quarter of our 225 students receive free or subsidized training. A summer Performing Arts Intensive program provides training in dance, literacy, music and drama. The organization is housed in a four-storey NYC Landmark building it rescued and rehabilitated into a dance conservatory in a long-term lease with NY City, for which the organization won a Preservation League award. The organization has created an active arts organization over the past 23 years, serving a working-class suburb of about 500,000 located on an island in New York Harbor, and reached from Manhattan only by ferry

Paul Tharp, the unpaid Executive Director and a co-founder of the organization, provided a line of credit of up to \$180,000 for the organization to cover emergency costs and unexpected deficits due to the devastation of Hurricane Sandy three years ago that caused numerous deaths and wrecked the local economy, leaving behind losses and damages in excess of \$1 billion.

Even now three years later, the local economy is still attempting to recover, causing an apparently permanent setback to the arts community.

The line of credit, guaranteed and secured by Paul Tharp through Santander Bank, NA, is interest-free to the organization, and is payable on demand with reasonable notice to the Board of Directors. The credit line and its terms were approved unanimously by the Board of Directors. The original amount was increased to \$250,400 at the start of FY 2015, and reduced by \$53,000 at the end of the year to \$197,400 through servicing the credit-line.

There is no expectation of default, due to the liberal terms in servicing the credit-line as well as continuing forbearance during the economic recovery locally.

As of filing date April 18, 2016, the Board's finance committee is still awaiting results of an auditor's review in progress to determine if any prior period adjustments are needed, for which an amended report would be forthcoming immediately. The progress of the review is discussed in the following Part XII. Financial Statements and Reporting.

Financial statements have been compiled by management and the Board's finance committee with the oversight our new auditor-of-record, Loralyn Hazem, CPA, Arlia & Associates, 10 Jefferson Blvd, Staten Island, NY 10312. Ms. Hazem was engaged in the past year to provide auditing services following the abrupt departure of our previous auditor of the prior five years. Our previous auditor declined - on the eve of a 2014 filing deadline - to go forward with the project unless we increased our \$5000 fee to more than \$9000, despite his engagement letter for a \$5000 fee and our payment made in advance. The auditor was unwilling to negotiate his higher fee demand, and held onto our books and records until we released him from his responsibilities in the engagement letter, at which time he would allow us to retrieve our documents and refund our previous payment. We agreed to release him. The events are demonstrated in a series of emails with the auditor. After a thorough search for a new auditing firm, the Board engaged Arlia & Associates, which has been reviewing our two most recent fiscal years, which had been impacted by the prior auditor's abdication. Subsequently, we learned anecdotally in industry reports that some accountants were increasing fees substantially to compensate for potential loss of audit fee income resulting from New York State's Nonprofit Revitalization Act in 2014. Among reforms, the act eased audit burdens of nonprofits under \$500,000 revenue, allowing use of CPA Independent Reviews which normally have lower fees than more the involved CPA audits, while also assuring full disclosure and equal merit. Indeed, our organization's utmost priority is to continue its compliance in all its reporting requirements. The organization anticipates the urgent delivery of its CPA reviews in coming weeks for properly amending this report in a timely and satisfactory manner.

Lines 2a., 2b., 2c., and 3b. were answered as "yes" because auditor reviews of records for two fiscal were already in progress in 2015.
