 The Arcadia Promise affirms that students will have a distinctively global, integrative, and personal learning experience that prepares them to contribute and lead in a diverse and dynamic world. Arcadia offers unique programs such as the University-subsidized Preview program, which takes nearly 60 percent of the incoming class each year to more than a dozen international destinations as a part of their coursework, Global Field Study courses, which combine a semester of intense study on campus with an embedded study abroad component, and semester-long or yearlong component study abroad experiences. The College of Global Studies at Arcadia University offers a wide range of academic programs at Arcadia study and research centers as well as at leading universities around the world.

 ENSURING ACCESS to quality higher education to students from economically challenged families 32% of Arcadia's 673 new entering Fall 2014 freshmen would be the first in their families to graduate from a college, 37% of them received need-based federal Pell Grants (awarded by federal formula to students from low-income families), 2% were covered by PA Act 101 (for those whose cultural, economic, and educational disadvantages might impede their ability to succeed in college) In addition to these state and federal programs, Arcadia provides financial assistance in the form of grants and scholarships to 99% of full time undergraduate students Among the entire Arcadia undergraduate population of 2,594 students enrolled during the fall 2014, 35% were receiving Pell Grants, 32% would be the first in their families to graduate from college, 2% were covered by Act 101, and 93% received University-financed financial assistance, 60% received Work Study support Arcadia also provides academic support through the Gateway to Success program, which includes Act 101 services for PA residents who qualify at 200% of the poverty level and provides personal attention and resources throughout the academic year to help them succeed

 Ensuring a GLOBAL OPPORTUNITY for as many students as possible Arcadia is distinct in that all of our students--undergraduate and graduate alike--engage in integrative, real-world learning opportunities such as internships, evidence-based research, service learning, interdisciplinary study, problem-based learning, and co-curricular learning experiences that expand beyond the traditional classroom 74% of the undergraduate class graduating in May 2015 had used their passports while they were students at Arcadia In 2015, 397 freshmen and 48 transfer students studied in 20 locales around the globe during spring break, as part of an academic (2-credit) program 88 freshmen studied abroad for a semester during their first year, in either England or Scotland, and 590 other Arcadia students studied abroad during 2014-15 The University has adopted a "Global Connections" undergraduate curriculum that ensures immersion with global issues through study abroad or a domestic global experience Graduate programs also include either curricular or co-curricular (e.g., pro bono service) requirements and/or opportunities for our students In addition to more than 4,000 students on its U.S. campuses, Arcadia provides educational opportunities at its centers and programs around the world to more than 2,500 students annually from other colleges and universities through The College of Global Studies at Arcadia University
