The regions they serve are some of over twenty targeted areas by the World Health Organization to combat various degenerative diseases such as Heart and Stroke diseases. Some of these diseases are spreading at epidemic rates. The lack of properly equipped facilities and medical supplies further contributes to the ongoing challenge of saving lives - especially the children, elderly and the handicapped. Several thousand people were served by these In-Kind Contributions.
