The College has no amounts accrued for interest or penalties as of May 31, 2015. The College does not expect the total amount of unrecognized tax benefits to significantly change in the next 12 months. The College has applied this criterion to all tax positions for which the statute of limitations remains open. The tax years open to examination by tax authorities under the statute of limitations include fiscal 2012 through 2014. The College has determined that its tax provision satisfies the more likely than not criterion, and that no provision for income taxes is required at May 31, 2015.

Salary data is reviewed and set annually by the President for positions reporting to the President, which is then reviewed with the Chair and Vice Chair of the Board of Trustees. These procedures were undertaken in our fiscal year which was June 1, 2014 through May 31, 2015, and calendar year 2014. During fiscal year 2014-2015 a Compensation Task Committee was formed with advisory council from Trustee members. The Compensation Task Force Committee was charged to benchmark salaries to independent data from like institutions.
