High school students enter the National Merit Program by taking the Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT) - a test which serves as an initial screen of approximately 1.5 million entrants each year and by meeting published program entry/participation requirements. For fiscal year 05/31/15 the National Merit Scholarship Program included Four-Year Renewable Scholarships 24,502 recipients One-Time Awards 2,715 recipients

	The National Achievement Scholarship Program is an academic competition established in 1964 to provide recognition for outstanding Black American high school students. Black students may enter both the National Achievement Program and the National Merit Program by taking the Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT) and meeting other published requirements for participation. A student's standing is determined independently in each program. Black American students can qualify for recognition and be honored as Scholars in both the National Merit Program and the National Achievement Program, but can receive only one monetary award from NMSC. For fiscal year 05/31/15 the National Achievement Scholarship Program included 331 recipients One-Time Awards 700 recipients. With the conclusion of the 2015 program, the National Achievement Scholarship Program will undergo a transition. Beginning in 2016, NMSC is forging a new relationship with United Negro College Fund (UNCF), the nation's largest and most effective minority education organization. UNCF will carry on the name and legacy of the National Achievement Scholarship Program through a newly designed program for college graduates. The new program, which will be administered by UNCF and underwritten by the National Achievement Scholarship Program, will honor and award financial assistance to high-achieving, underrepresented college graduates.
