 SwedishAmerican Foundation (SAF) supports SwedishAmerican Hospital, a 501(c)(3) organization, in its mission to provide quality medical healthcare to communities in Northern Illinois and Southern Wisconsin regardless of race, creed, sex, national origin, handicap, age or ability to pay. During the current year, SAF provided additional funding grants to SwedishAmerican Hospital for a meditation garden and a shuttle service for the new SwedishAmerican Regional Cancer Center which opened in October of 2013. In addition, smaller grants were provided to specialized departments within the SwedishAmerican Hospital, which helped enhance patient care and patient-visitor comfort.

4b (Code ) (Expenses \$ **271,216.** including grants of \$ **0.** ) (Revenue \$ **0.**)  
 In 2005, SwedishAmerican Foundation (SAF), as part of its mission to revitalize the neighborhood surrounding the SwedishAmerican Hospital campus, purchased and renovated a group of run down rental housing units directly across the street from the hospital campus, for the purpose of providing safe, secure, and affordable near-campus housing for on-call hospital staff and medical students from the University of Illinois Rockford campus who are interning at SwedishAmerican Hospital. Program expenses relating to this mission project include the services of a salaried property manager in addition to all of the rental unit expenditures relating to repairs, maintenance and utilities which are also provided by SAF.

4c (Code ) (Expenses \$ **69,374.** including grants of \$ **0.** ) (Revenue \$ **0.**)  
 Beginning in 2004, the SwedishAmerican Foundation (SAF) Board of Directors approved \$360,000 to be designated as funding for a neighborhood revitalization program. SAF has purchased a total of 30 older homes in the six block area surrounding SwedishAmerican Hospital for the purpose of making them saleable to employees, firefighters, police officers, and public school teachers at a price less than cost of purchase and renovation. To date, 26 of the homes were sold to owner-occupants. Proceeds from the sale of the homes are recycled back into the program upon sale of the renovated home. During the fiscal year, SAF incurred over \$69,000 in operational expenses for utilities, property taxes, lawn care, snow removal, and minor repairs and maintenance on the properties that were in various stages of
