who will enrich their community and God's Kingdom.

CPLS provided a hot lunch program for its students and faculty,
designed to offer nutritionally adequate, appealing, and affordable
meals, with the goal of enhancing the educational experience through

CPLS provided inter-scholastic athletic programs to its middle and
