

The organization's parent activities are mainly focused on training, supporting, and providing resources for the subsidiary chapters, who deliver program services. A total of 12 staff persons support over 6,270 volunteers. Staff also administers the scholarships for therapists program, which awarded 264 scholarships, as well as the Therapeutic Tricycle Program; which makes awards in all fifty states. Chapters reported an estimated 6,270 volunteers who provided 69,000 hours of community service. Chapters provided an estimated 1.5 million dollars in grants to programs. Additionally, chapters First Accomplishment provided more than 2,641 therapeutic bicycles to kids with disabilities; more than 24,593 since inception.
