HOWEVER, DUE TO THE HIGHER COST OF THESE INCLUSIVE PLAYGROUNDS, MANY LOCAL GOVERNMENTS CANNOT AFFORD THEM. SOUTHWEST AMBUCS GOAL IN BUILDING THE PARK IS TO ALLOW CHILDREN OF ALL AGES AND MOBILITIES THE OPPORTUNITY TO FULFILL THEIR NEEDS AND DESIRES TO PLAY, LEARN, PRETEND, SOCIALIZE, BUILD STRENGTH, TEST THEIR ABILITIES, AND HAVE FUN. WHEN KIDS WITH AND WITHOUT DISABILITIES PLAY TOGETHER, THEY LEARN TO APPRECIATE EACH OTHERS' ABILITIES AND SIMILARITIES. ACCESSIBLE ROUTES THROUGHOUT THE PLAYGROUND WILL ALLOW PARENTS, GRANDPARENTS, AND CAREGIVERS WITH OR WITHOUT THE CAPABILITY TO MOVE EASILY AROUND THE PLAYGROUND TO SUPPORT AND PLAY WITH THEIR CHILDREN. THE PLAYGROUND WILL SERVE ALMOST 25,000 CHILDREN AGES 5-15 IN THE TEXAS PANHANDLE. LIVING WITH SOME TYPE OF DISABILITY. THE PARK WILL BE LOCATED IN MEDIT-PARK, WHICH IS CLOSE TO THE HOSPITALS AND MANY PHYSICAL AND OCCUPATIONAL THERAPISTS IN AMARILLO. IT WILL MEET STANDARD ADA REQUIREMENTS AS WELL AS CONSUMER PRODUCT SAFETY COMMISSION (CPSC) GUIDELINES. THE AMBUCS PLAYGROUND WILL PUT SAFETY AND CONVENIENCE FIRST WITHOUT SACRIFICING FUN.
