THE COLLEGE IS ACCREDITED BY THE SOUTHERN ASSOCIATION OF COLLEGES AND SCHOOLS COMMISSION ON COLLEGES. THE COLLEGE'S 2014 ENTERING FRESHMAN CLASS OF 577 HAD THE HIGHEST SAT SCORE OF AN ENTERING CLASS.
