THE SCHOOL HAS AN AUDIT COMMITTEE AS IN PRIOR YEARS. THE PROCESS OF
SELECTING AN INDEPENDENT AUDITOR AND OVERSEEING THE AUDIT HAS NOT
CHANGED FROM THE PRIOR YEAR.
