The Junior League of Jackson MS, Inc (JLJ) further defined its Issues Based Community Impact Framework The framework design helps to further educate members, corporate sponsors, and community partners about how the League is working to maximize its impact on the Community Community projects focus on the issues of Early Literacy, Nutrition, Physical Fitness, Social and Emotional Wellness, and Teenage Pregnancy Prevention The JLJ hosted a Community Roundtable for local nonprofit leaders during which experts provided information on the state of early childhood education in Mississippi The JLJ volunteers planned and led five summer camps focused on the issues of Early Literacy, Nutrition, Physical Fitness, Social and Emotional Wellness, and Teenage Pregnancy Prevention This year 300 students were impacted by these projects that included activities in reading, writing, math, music/drama, physical fitness, arts/crafts, conflict resolution, and the understanding of staying in school Additionally, volunteers coordinate meals and snacks, motivational assemblies, and field trips The JLJ partnered with the Community Foundation of Greater Jackson to award over \$100,000 in grants to Jackson Public Schools and teachers with various community partners The JLJ volunteers partnered with the Mississippi Food Network to pack and deliver 4,950 backpacks with nutritious food for children and their families at Brown and Johnson Elementary, whom school nurses and teachers identified as being "food insecure" outside of school In addition, volunteers packed boxes of food for families at Thanksgiving Also, the JLJ hosted its first Junior League Jumble which serves as both a community and fund development project and is the ultimate rummage sale JLJ members generously donated gently used merchandise sold at the event Funds from the sale helped support the mission of the League while providing the community the opportunity to purchase quality items at bargain prices Finally, the JLJ hosted Touch-A-Truck which is also both a community and fundraising developmentproject Over 7,000 children attended the event which allows children to Explore, Climb, and Touch trucks, emergency response vehicles, heavy machinery and other equipment
