NOTE A- Summary of Organization

United Care U.S.A., Inc. is a national public charity, chartered as a non-profit 501-c-3 membership corporation, exempt from federal and state taxes, and supported by public contributions. The central charitable purposes are to promote awareness and prevention of child abuse, abduction and exploitation; distribute free publications and educational information to concerned citizens; promote volunteerism and self-help groups; sponsor film presentations for schools, kindergartens and civic organizations; maintain nationwide 24 hour toll-free 800 "child abuse hotline"; and educate the public relating to the mental health and well-being of exploited, battered, emotionally and sexually abused children under 18 years of age.

NOTE B - Summary of Significant Accounting Policies

Program revenues and expenses are recorded on the cash basis of accounting which records contributions as they are received and records operating expenses as they are paid.

Membership list development costs are substantial and in accordance with generally accepted accounting principles. United Care U.S.A., Inc. recognizes these as they are incurred against operations, even though the membership list may provide significant benefit to future periods.

Fixed assets are being depreciated over 5-7 years using the straight-line method.

Organization costs are being amortized over a five-year period.
