In addition, the Organization write-offs decreased approximately \$4.3 million from approximately \$7.0 million for the year ended May 31, 2014 to approximately \$2.7 million for the year ended May 31, 2015. Write-offs for the organization continue to decrease as the result of Medicaid expansion and changes in payer mix.
