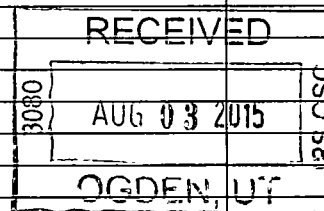

4. Applicant must be of good character as evidenced by at least three (3) letters, two of which must be from teachers, principals, counselors, etc., from the institution they are currently attending.
5. Applicant must demonstrate a coherent degree plan and willingness to pursue a course of higher education.
6. Economic need of the applicant will be given secondary consideration.
7. Applications must be received no later than 5:00 p.m., March 15th for the fall semester. Awards will be announced by May 1st.
8. The first half of the scholarship will be made payable to the student and/or the institution upon verification of enrollment. Upon completion of the first semester, a statement will be required from the institution certifying that the applicant is considered by the registrar to be a regular student in good standing with a grade point level of at least 2.5 on a scale of 4.0. Upon receipt of this statement and proof of enrollment for the second semester, the additional one-half (1/2) of the scholarship will be issued.
