This past year OSB provided 2,012 economically disadvantaged students who attend elementary schools in the Santa Ana Unified School District (SAUSD) with two complete school uniforms consisting of two tops, two bottoms, a sweatshirt, a pair of new shoes, and five pairs of underwear and socks. The students also received a new backpack filled with school supplies, a new book of their choice, and a packet of personal hygiene items including a toothbrush and toothpaste. OSB, located at the Assistance League of Santa Ana's facility, is the only organization providing free uniforms to children in SAUSD. The program is volunteer operated, and all contributions go directly for tangible supplies that are passed on to the students at no cost to them.

4b (Code:) (Expenses \$ 124,997. including grants of \$ 61,537.) (Revenue \$)Community Assistance

Provides philanthropic services to residents of Santa Ana including holiday gifts and activities at French Park Care Center, Holiday Gift of Giving to migrant worker families, Senior Prom for seniors, assistance to local women's shelters, a retail rehabilitation program, and community neighborhood meetings.

4c (Code:) (Expenses \$ 124,064. including grants of \$) (Revenue \$ 9,674.)Dental Center

Located at the Assistance League of Santa Ana's facility, provides low-cost dental care to uninsured students from kindergarten through twelfth grade. In 2014/2015 we provided dental care, which included examinations, teeth cleaning, full-mouth xrays, fillings, root canals, and extractions to 479 children. The Dental Center is staffed by licensed dentists, dental hygienists, bilingual office staff, and volunteers. Patients receive individual instruction on proper oral care and nutrition and are given a dental hygiene kit by the volunteers.

Unique to the scholarship program is that each student also receives one-on-one mentoring from an Assistance League member volunteer while attending college. Many recipients are the first in their family to attend college. Each year between 20-25 scholarships are awarded and presented at a spring reception at the Assistance League facility for the recipients' families, teachers, principals, and SAUSD guests.

Other programs include our Serving Eager Eyes (SEE) program in addition to other programs. Our SEE program provides an eye examination and eye glasses for qualifying students of the Santa Ana Unified School District. Students are identified and referred by the school nurse as being in need of this service. In fiscal year 2014/2015, 78 students were served through this program.
