Retail With 1,282 employees, the retail division collected over 46 million pounds of donated goods from communities throughout Maine, New Hampshire and northern Vermont Those goods, along with other items, were sorted, processed and priced for sale in 30 stores and two buy-the-pound outlets Through sustainable processes that serve the well-being of people and our planet, while generating revenue in support of operations and our own workforce services, the division attained a waste stream diversion rate in excess of 71% on its path toward zero waste T-shirts and other textiles that were not saleable condition were repurposed into industrial wiping cloths or baled and sold in the aftermarket Items not in working condition have parts that are sold in the aftermarket, along with items not sold through retail outlets Computer donations are sorted for their highest and best use through our Good Tech initiative or responsibly recycled through our partnership in Dell Reconnect The retail division provides job training opportunities for our Workforce Services participants as appropriate
