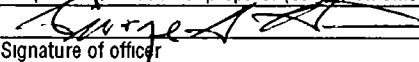

**Community-Based Services:** Maine Family Planning (MFP) provides funding, technical support, and quality assurance to 29 clinics statewide, in addition to offering direct services at 18 clinics in Augusta, Bangor, Belfast, Calais, Damariscotta, Dexter, Ellsworth, Farmington, Fort Kent, Houlton, Lewiston, Machais, Norway, Presque Isle, Rockland, Rumford, Skowhegan, and Waterville. Using a sliding-fee scale, MFP serves 22,186 low-income Maine women, men and teens annually with expert and confidential services that include:

- comprehensive and medically accurate reproductive health care information to help clients make informed decisions about their reproductive health and lives;
- gynecological exams;

**Education and Research Projects:** Designed with input from Maine teens, [www.maineteenhealth.org](http://www.maineteenhealth.org) provides sexual health information, a guide to Maine's family planning clinics, and an interactive place to get answers to their sexual health questions. MFP's text messaging service, AskMTH, allows teens to use their cell phones to text anonymous questions and get answers from a trained family planning professional. In FY 2015, our text line fielded 183 questions from 51 different teens, indicating that teens find the service useful and return to it again and again. During the same time period, our teen website received and answered 95 emailed questions from Maine teens.

**Agency and Mission-Related Projects:** Since 1971, MFP's Public Affairs staff has worked to protect the reproductive rights of all Maine citizens. MFP is founded on the premise that Maine women and teens must have access to comprehensive reproductive health care and information in order to control their reproductive lives. MFP's Public Affairs efforts are designed to promote and protect programs and services statewide to ensure affordable access to family planning.

In FY2015, MFP focused much of its advocacy efforts on defeating two bills that would have increased barriers to abortion care in Maine. Both bills were defeated in legislature:

According to 2010 data (the most recent available), Maine is tied with  
Massachusetts with the fourth lowest teen pregnancy rate in the nation.

MFP administers a Women's, Infants and Children (WIC) program in

Washington and Hancock counties. The WIC program provides nutritious

foods, nutrition education (including breastfeeding promotion and support), and referrals to health and other social services to participants at no charge. WIC serves low-income pregnant, postpartum and breastfeeding women, and infants and children up to age 5 who are at nutrition risk. In FY15, the WIC program served 1,763 people.

Form 990, Part III, Line 4b, Program Service Accomplishments:

Prevention Coordinators worked with educators in 23 schools and community based organizations statewide to help them deliver a variety of evidence-based, comprehensive sexuality education curriculums focused on preventing HIV/STDs and pregnancy, reaching over 1,600 middle and high school students. To sustain sexuality education efforts we continue to provide training and professional development through in-person trainings and a statewide conference. In the past school year (2014-15), a total of 366 educators from schools, youth-serving organizations and government agencies attended these training opportunities.

During FY2015, the MFP's Teen Pregnancy Prevention Program also continued its work through the federally funded Personal Responsibility Education Program (PREP), partnering with Jobs for Maine's Graduates (JMG) to deliver evidence-based programming. During the 2014-15 school year 464 students participated in the All4You! curriculum in 19 high schools located in Maine communities with high teen pregnancy rates. Evaluations showed increased knowledge and improved attitudes around HIV/STDs, pregnancy prevention, and behaviors that put teens at risk and preventive measures like abstinence, birth control and condom use.

Similar to our community-based services, funding for the MFP's

education and research projects is provided by State and Federal agencies (that also monitor program operations and outcomes), foundation grants and other restricted revenues.

on Minors and Incapacitated Persons, would have repealed Maine's longstanding, successful, Adult Involvement Law, and require minors seeking an abortion to bring a legal parent to the clinic with them to consent to the procedure.

\* LD 1312, An Act to License Outpatient Surgical Abortion Facilities, would have arbitrarily increased state regulation and scrutiny of clinics that provide abortion services. This increased scrutiny would not have applied to physicians who provide abortion services as part of their private practice; it would only apply to the three not-for-profit, publicly-available providers in Maine.

MFP also worked to pass bills that will advance reproductive justice in Maine, including LD 319, a bill (now law) that will provide Family Planning services for more low-income Mainers. This law will provide reproductive health coverage for an estimated 13,000 Mainers who make too much to qualify for MaineCare, but are still making a relatively low income (209% FPL) and don't have private health insurance. Our Public Affairs and Communications departments also collaborated with other organizations and coalitions to pass Employment Protections for Survivors of Sexual Assault or Abuse, General Assistance for Asylum Seekers, Guidelines for the Shackling of Pregnant Women, and de-felonization of Nonviolent Drug Crimes.

Each new legislative session brings new legislators who require education to dispel myths about reproductive health care and rights, and to help them recognize reproductive health care as basic health care, rather than simply a political issue. We continue to rely on a strong network of pro-choice, pro-family planning grassroots activists who communicate very powerfully with their elected representatives, and will continue to be vigilant in protecting and expanding access to the full range of reproductive health care for all women, men and teens in Maine.

Private contributions and agency-endowed resources fund these projects. No public funds are used.
