Explanation: Our treasurer position changed hands at the end of school year 2014-2015. The new treasurer made false claims about having that tax returned prepared by a licensed tax preparer by the due date of 11/15/15. Unfortunately the current board did not check to see if the return was filed. It only became apparent in late May of 2016 that she did not file the return. This was discovered when she was removed from her position because of suspicion of theft. The board is pursuing legal actions against her. A new treasurer, Linda Kavanah, was appointed in the beginning of June. She is overseeing the completion this tax return.
