DMV Outreach - Focuses on educating Division of Motor Vehicles Examiners and State-level leaders about the important partnership between the NC Donor Registry and Donate Life NC. We also provide information and volunteers through the DMV offices to educate the public as they get ready to be asked whether they want to register as a donor when they get their driver's license. There are 545 DMV Examiners and we trained about 100 new ones this past year. We have 60-75 volunteer DMV Ambassadors who have visited those offices quarterly, updating materials and sharing data on office donor designation rates. By the end of June 2015, more than 4.6 million North Carolina donors were registered through the DMV.
