Art Museum The Currier, an internationally renowned art museum, is New Hampshire's largest art museum with world-class European and American art collections of more than 13,500 objects that are at the core of its education, studio, and exhibition programs An annual roster of 4-5 special exhibitions complements the permanent collection displays, each interpreted through a range of programs including guided tours, hands-on art making activities, artist talks, and on-line curriculum for educators There were approximately 67,186 visitors to the Museum in FY15, 7,836 of which were from student groups In addition to exhibition galleries, the Museum facility includes two classrooms, a 180-seat auditorium, winter garden, Museum Shop, cafe, and entrance plaza The Currier's website (www.currier.org) provides information on all of our programs

The value of the objects acquired by gift, for which the Museum can make a reasonable estimate, totaled \$576,000 and \$375,700 for the years ended June 30, 2015 and 2014, respectively. An estimate of the total value of objects acquired by gift in years prior to 1997 is not readily determinable. The total value of gifts received since 1997 is \$11,808,195. The total value of objects purchased from December 31, 1997 through June 30, 2015 and 2014 was \$21,217,980 and \$19,825,482, respectively. For the years ended June 30, 2015 and 2014, the Museum sold deaccessioned collections and objects of art totaling \$110,712 and \$28,847, respectively. The selling price of these items approximated their fair value.
Part III, Line 4	The Currier is New Hampshire's largest art museum with world-class European and American art collections of over 13,568 objects that are at the core of its education, studio, and exhibition programs. Comprised of the Museum, the Art Center, and the Frank Lloyd Wright-designed Zimmerman House, the Currier received reaccreditation from the American Alliance of Museums in November of 2012. In its 86-year history, the Museum has built collections of both international stature and regional importance. Today, the Museum's holdings of more than 13,568 objects include major works by such European masters as Tiepolo, Constable, Monet, Picasso, and Matisse, among many others. The American art collections are the most comprehensive in northern New England, and include works by Homer, Hassam, O'Keeffe, Calder, and Gottlieb, as well as extensive holdings of sculpture, photography, glass, silver, pewter, and furniture. The caliber of the collections matches that of many major metropolitan museums, and objects are frequently loaned to museums around the world. The Currier has a long-standing commitment to collect the best art made in New Hampshire in order to reflect the region's vital cultural traditions. An annual roster of 4-5 special exhibitions that complements the permanent collection displays are interpreted through a range of programs including guided tours, hands-on art making activities, artist talks, and through such resources as family guides. Approximately 7,836 students visit the Currier each year on a formal tour program. The Art Center offers year-round studio programs with annual enrollments of over 1,467 students from 40 surrounding communities. The Zimmerman House draws about 4,610 visitors annually on guided tours of about 13 visitors each. Outreach programs reach public schools, libraries, social service agencies and community organizations throughout New Hampshire. The Currier's collections are accessible to the public through the online collections database (www.currier.org), which includes images and basic data for all 13,568 objects in the collections. It also provides supplemental information to support the online curriculum for educators (curriculum.currier.org). The Currier's mission, approved by the Board in 1994, embraces the following principles: The Currier Museum of Art is committed to providing stimulating, diverse, and enjoyable encounters with original works of art and, in so doing, hopes to inspire the hearts, minds, and imagination of its members and visitors. It is dedicated to high standards of exhibition, preservation, research, interpretation and education, and enhancement of its collection. The Currier is determined to serve all age groups and a culturally varied audience from New Hampshire and the surrounding region. The Currier's vitality depends upon its responsiveness to changes in the arts and in society while maintaining a sound financial base on which to expand its activities.
Part V, Line 4	The endowment funds are used for Museum operations, art acquisition, conservation, library book purchases, and scholarships.
Part X, Line 2	The Internal Revenue Service, in a letter dated July 16, 2004, determined that the Museum is a publicly-supported charity under Internal Revenue Code Section 501(c)(3) and, therefore, not subject to federal income taxes or federal excise taxes imposed upon private foundations. Tax-exempt organizations could be required to record an obligation for income taxes as the result of a tax position they have historically taken on various tax exposure items including unrelated business income or tax status. In accordance with accounting principles generally accepted in the United States of America, assets and liabilities are established for uncertain tax positions taken or positions expected to be taken in income tax returns when such positions are judged to not meet the "more-likely-than-not" threshold, based upon the technical merits of the position. Management has evaluated the Museum's tax positions taken on its filed tax returns and concluded that the Museum has maintained its tax-exempt status, does not have any significant unrelated business income and has taken no uncertain tax positions that require adjustment to the financial statements.
