Background and History Lund helps children thrive by empowering families to break cycles of poverty, addiction, and abuse Lund offers hope and opportunity to families through education, treatment, family support and adoption Founded in 1890, as a maternity home for unwed mothers, Lund has evolved to meet the most pressing community human service needs in Vermont Our name too has evolved from the Home for Friendless Women to the "Elizabeth Lund Home" to the Lund Family Center and more recently "Lund" Lund is the largest and oldest private non-profit adoption agency in Vermont, having finalized more than 9,000 adoptions since 1890 Lund has been for many years the only comprehensive, therapeutic residential treatment program in the State of Vermont for women who are pregnant and parenting, where they are not separated from their young children Over the years, Lund staff members have received a number of national, regional and local awards distinguishing them for their service to the

Lund provides comprehensive, gender-specific, trauma-informed residential and outpatient treatment for pregnant and parenting women with substance abuse and mental health diagnoses Lund partners with the State of Vermont to provide substance abuse screening for families with risk of child abuse or neglect, increasing the well-being and safety of children Through Lund's programs, 130 mothers and 74 children engaged in gender-specific, family-centered treatment for substance abuse disorders and mental health issues 394 parents were interviewed and screened for substance abuse in collaboration with the State of Vermont 100% of babies born at Lund were free of illicit substances

Lund provides a continuum of Family Support and Education Services The Early Childhood Education Program stimulates crucial early brain development and promotes school readiness The program serves 50 children, aged 2 weeks to 5 years The New Horizons Educational Program is a licensed high school completion program for pregnant and parenting young women Parenting, life skills and career exploration are integrated into the curriculum Lund's family support services increase parents capacity to provide for their children, foster social and emotional competence and promote healthy relationships through parenting education, job training and assistance in removing barriers to self sufficiency Transitional housing is provided for mothers, with their children, who are enrolled in workforce development/welfare to work programs Lund's Early Childhood Education program ensured 59 children enjoyed high quality early education and care While they were enrolled, their families were connected to needed resources and services in the community Our Early Childhood Program serves a population with a high level of needs with 71% of enrolled children living in poverty and at risk of abuse, neglect and school failure Our New Horizons Educational Program provided high school completion and postsecondary readiness to 33 pregnant and parenting teens and young women In New Horizons, 6 culminated their high school careers, receiving their High School Diploma, 16 lower grade level mothers transitioned successfully back to their sending schools or other educational programs, and 100% of the young mothers made academic progress during the year Lund's Family Services Programs support parents and their families with education, work training, housing and financial assistance 203 parents raising 270 children living in poverty received Reach Up Case Management and financial assistance, seeking to increase their self-sufficiency through work placement, vocational training and education Of these, 88 parents attained paid employment during the fiscal year, 124 engaged in job training, and 37 families transitioned from Reach Up due to paid employment Lund's Kids-A-Part program aims to keep families connected when the mother is incarcerated By offering a variety of services, including education and advocacy, as well as direct services such as parenting education, grief and loss counseling, communication skills, financial assistance and referrals to other community resources to children and families affected by a parent's incarceration, we work to lessen the negative effects of separation during this challenging time in a family's life These services take place both inside the correctional facility and in the community 253 incarcerated mothers received parenting support services 141 families of incarcerated women received case management ensuring their connection to resources and services Other results of the Family Services Programs at Lund were 150 families benefited from family education and parenting skill development in their home and in Lund's residential facility 12 mothers and their 13 children benefited from transitional housing and programming seeking to prepare families for independent living and build their self-sufficiency 768 middle and high school students were educated on teen pregnancy and the importance of prevention in schools and community organizations around the state
