VLT AND THE LANDOWNER SIGNED AN UPDATED BASELINE DOCUMENTATION REPORT ASSOCIATED WITH THE EASEMENT MODIFICATION. VLT'S BOARD OF TRUSTEES APPROVED THE MODIFICATION. BOURNE/FRIEND/PIERSON, WOODSTOCK & POMFRET, VT - FURTHERED THE CONSERVATION PURPOSES OF THE EASEMENT BY ADDING APPROXIMATELY 84 ACRES (25.5 OF WHICH ARE SUBJECT TO PRE-EXISTING CONSERVATION RESTRICTIONS HELD BY THE TOWN OF POMFRET) TO THE EASEMENT. IN ADDITION, THE EASEMENT ALLOWS FOR A RUSTIC CAMP AND MINOR RECREATIONAL STRUCTURES TO BE BUILT ON THE NEWLY CONSERVED LAND, THE DIVISION OF THE FARM PORTION OF THE PROPERTY (MOST OF WHICH CONSISTS OF THE ORIGINALLY CONSERVED LANDS) AND THE FORESTED PORTION OF THE PROPERTY (ENTIRELY CONSISTING OF THE NEWLY CONSERVED LANDS), AND PRIMITIVE ACCESS TO A SIMULTANEOUSLY BUT SEPARATELY CONSERVED ADJACENT PARCEL TO THE NORTH. THE AMENDMENT UPGRADED THE WATER SUPPLY AND WASTEWATER CLAUSE TO MODERNIZE THE EASEMENT LANGUAGE TO BE CONSISTENT WITH VERMONT LAW. THE VALUE OF THESE ADDITIONAL RESTRICTIONS WAS DONATED TO VLT AND SUBSTANTIATED BY AN APPRAISAL CONDUCTED BY AN INDEPENDENT THIRD-PARTY APPRAISER. VLT AND THE LANDOWNER SIGNED AN UPDATED BASELINE DOCUMENTATION REPORT ASSOCIATED WITH THE EASEMENT MODIFICATION. VLT'S BOARD OF TRUSTEES APPROVED THE MODIFICATION. CHAMPLAIN VALLEY COHOUSING, CHARLOTTE, VT - PURSUANT TO A SETTLEMENT NEGOTIATED IN LIEU OF CONDEMNATION, VLT RELEASED A 0.22 ACRE PORTION OF THE 116.4 ACRES OF CONSERVED LAND TO ALLOW THE CONVEYANCE OF SUCH PARCEL TO THE VERMONT AGENCY OF TRANSPORTATION ("AOT"). THE RELEASE WAS REQUIRED BY AOT'S HIGHWAY WIDENING AND IMPROVEMENT PROJECT. SPECIFICALLY, THE 0.22 ACRES WILL BE USED TO BUILD A PEDESTRIAN UNDERPASS CONNECTING RECREATIONAL TRAILS LOCATED ON CONSERVED LANDS ON BOTH SIDES OF THE HIGHWAY. THE RELEASE HAS A DE MINIMUS IMPACT ON THE CONSERVATION VALUES OF THE PROPERTY BECAUSE THE 0.22 ACRES DOES NOT SUPPORT ANY MEANINGFUL AGRICULTURE OR FORESTRY USE, AND DOES NOT HAVE NATURAL RESOURCE/ECOLOGICAL VALUE. VLT RECEIVED 50% OF THE PROCEEDS OF THE SETTLEMENT TO COMPENSATE VLT FOR ITS LOST PROPERTY INTEREST. AS REQUIRED BY THE EASEMENT, VLT WILL USE THE PROCEEDS TO PRESERVE UNDEVELOPED AND OPEN SPACE LAND IN THE STATE OF VERMONT. THE VLT BOARD OF TRUSTEES APPROVED THIS TRANSACTION. THIBAULT, CHARLOTTE, VT - THE PURPOSES OF THE THIBAULT FARM CONSERVATION EASEMENT ARE TO CONSERVE PRODUCTIVE AGRICULTURAL AND FORESTRY LANDS, SOIL RESOURCES AND THE ESSENTIAL CHARACTERISTICS OF THE VERMONT COUNTRYSIDE. THE MODIFICATION TO THE THIBAULT FARM EASEMENT STRENGTHENED THE PROTECTION OF THE AGRICULTURAL, FORESTRY AND OPEN SPACE VALUES OF THE PROPERTY BY ADDING AN OPTION TO PURCHASE AT AGRICULTURAL VALUE ("OPAV") TO THE PROPERTY. THE OPAV ONLY IS CO-HELD BY THE VERMONT HOUSING AND CONSERVATION BOARD ("VHCB"), AND THE VERMONT AGENCY OF AGRICULTURE, FOOD AND MARKETS ("VAAFM") AND TOGETHER WITH VLT AND VHCB, THE "CO-HOLDERS.") THE CO-HOLDERS PAID FULL FAIR MARKET VALUE FOR THE ADDITIONAL RESTRICTIONS, THE VALUE OF WHICH WAS DETERMINED BY AN INDEPENDENT APPRAISER. VLT AND THE LANDOWNER SIGNED AN UPDATED BASELINE DOCUMENTATION REPORT ASSOCIATED WITH THE EASEMENT MODIFICATION. VHCB, VAAFM AND THE VLT BOARD OF TRUSTEES APPROVED THIS MODIFICATION TO ENHANCE THE RESTRICTIONS ON THE THIBAULT FARM. METCALF, NORWICH, VT - THE PURPOSES OF THE METCALF CONSERVATION EASEMENT ARE TO CONSERVE PRODUCTIVE AGRICULTURAL AND FORESTRY LANDS, SOIL RESOURCES, SCENIC AND OTHER NATURAL RESOURCE VALUES, AND THE ESSENTIAL CHARACTERISTICS OF THE VERMONT COUNTRYSIDE. THE AMENDMENT ENHANCED PROTECTION OF THESE VALUES BY ADDING A "SCENIC PROTECTION ZONE" TO A PORTION OF THE PROPERTY WHEREIN THE LANDOWNERS SHALL NOT CONSTRUCT NEW CONTINUED ON SCHEDULE O.
