EJPs mission is to work with individuals and systems to break down the barriers that prevent survivors from accessing crucial economic resources. WHBW and Burlington Housing Authority BHA collaborate on an 11-unit apartment complex, Sophies Place. Advocates work with survivors as they stabilize housing in both Sophies Place and in scattered site transitional housing. In fiscal year 2015, we provided transitional housing services to 34 adults and children, for a total of 7,826 bednights. In fiscal year 2014, we provided transitional housing services to 33 adults and children for a total of 7,746 bednights. In fiscal year 2015, transitional rental assistance was provided to 91 adults and children for a total of 4,455 bednights. In fiscal year 2014, transitional rental assistance was provided to 21 adults and children for a total of 3,412 bednights.
