SUPER SATURDAY WORKSHOP. THIS PROGRAM PROVIDES AN EARLY OPPORTUNITY FOR PARENTS AND STUDENTS TO BEGIN WORK ON COMPLETING THEIR FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA) ONLINE, AND IS CONDUCTED IN JANUARY AND FEBRUARY (JANUARY 1 IS THE FIRST DATE FORMS MAY BE COMPLETED).
