	Division of Public Communications, Legislative and Governmental Affairs Division of Public Communications continued its ongoing efforts to educate and mobilize membership about MNA activities and programs, with similar efforts launched to educate and mobilize the general public and nursing community to support for a variety of issues related to nursing, safe patient care, health care reform initiatives as well as issues related to our union contract campaigns Special emphasis in 2015 was devoted to the provision of comprehensive marketing communications support to educate members about a new law that sets safe patient limits for nurses working in acute care hospital ICUs The Department of Legislation and Government Affairs continued working on the Legislative Agenda for the Association This included attending hearings, meetings with legislators, lobby days and many literature drops up at the State House Special attention was focused in late 2014 and 2015 on the implementation of the Association's ICU staffing law which was passed in June 2014 This included attending regulatory hearings and providing commentary throughout the regulatory process In addition the division monitors and tracks all legislation relative to health care and nursing and attends hearings and/or meets with legislators either in support or opposition
