United Way of North Central Massachusetts made \$2.2 million in grants and distributions during the year. In addition to its grantmaking, United Way is focused on mobilizing the caring spirit of the community through its volunteer center. The goal of these grants and distributions, and the work of our volunteers, is to provide immediate assistance to those in need, while creating a community where everyone has the opportunity for a better life. United Way creates these opportunities through its work in the areas of education, income and healththe building blocks for a better life. United Way’s priorities include youth development and education, substance abuse and domestic violence, and emergency food and shelter. In addition to funding 36 programs, which delivered over 140,000 health and human services, through local nonprofits, United Way also has community initiatives that include: United Way Youth Venture, which inspires and invests in teams of young people, to design and launch their own lasting social ventures; Dolly Parton Imagination Library, the newest program United Way launched. It is a preschool literacy program that provides children with a new, FREE, age-appropriate book each month from birth until their 5th birthday, regardless of socioeconomic status. This program ensures that children have quality books in the home in their most developmental years. Any child living in Ayer, Shirley, Fitchburg, Leominster, Gardner, Winchendon or Templeton may sign up for the program. The program is sending books to over 2,000 children every month. The United Way Volunteer Center promotes volunteerism through outreach efforts and its interactive website, www.community-builders.net. As a core function of the United Way of North Central Massachusetts, United Way Volunteer Center’s mission is to educate, inform, and inspire greater community involvement through new and innovative strategies. The United Way Center implemented a new software platform for its online website in February. The new software has improved ease of use for agencies and volunteers with increased and quality technical support for the Volunteer Center. Site analysis data indicates a 57.88% increase in site visits and 1,427 volunteer hours logged since 2/28/2015, the new software implementation date. Four Heroes Against Hunger meal events were organized by the Volunteer Center from February-June. 80,000 meals were distributed to thirteen food pantries as a result of the four events. The United Way of North Central Mass is the fourth largest contributor of meal packages in the New England region. Since the program inception, 255,546 meals have been packaged by participating volunteers. The United Way officially received its Service Enterprise certification from Points of Light in June, becoming the fourth non-profit in the North Central region to accomplish the extensive program requirements. The Volunteer Center collaborated with Mass Service Alliance to assist other non-profits in pursuing the certification during 2014. The Day of Caring continues to be the largest volunteer collaboration of the Volunteer Center. Local companies and community individuals support the North Central region non-profit agencies in this one-day event. In September 2014, 48 agencies participated with 66 projects completed by the 500+ volunteers and 2,000 area school students. Mass 2-1-1, which is sponsored by United Way, is a free information and referral service that connects residents to health and human services in the community. Hundreds of local residents have used the service. FamilyWise affords prescription discounts and savings to local residents that are uninsured or underinsured, saving area residents over \$1M since the program was launched locally. United Way’s Supplemental Basic Needs Fund delivers food and heating assistance, as additional needs are identified throughout the year. This past year over 2,700 individuals & families received assistance. United Way’s Emergency Shelter Fund provides shelter to homeless individuals during extreme winter events and situations. Over 282 individuals were helped with 570 nights of lodging. United Way once again hosted its annual heating forum, which provides critical information to nonprofit agencies on the various heating assistance programs.

United Way Youth Venture (UWYV) reaches out to young people and inspires them to take initiative and make a positive, lasting change in their communities. When young people learn early in life that they are powerful and capable of leading social change, they are more likely to continue to lead throughout their lives. UWYV is a three-way partnership between Ashoka’s Youth Venture, Mount Wachusett Community College, and United Way of North Central Massachusetts. This program is in 14 school systems and has reached over 8,941 students in the past year, actively engaging 4,250 students.

A special fund-raising campaign was initiated a couple of years ago in response to the increased need for Safety Net Services. This campaign proved critical to our being able to respond to a stubbornly high unemployment rate. One hundred percent of all funds raised were granted to agencies that had the network capabilities to get food and energy assistance to those most in need. This past year 2,743 individuals received assistance.
