By providing academic support through expert tutors in small-group settings, New Hope partners with parents and students in meeting the increasing demands of their curriculum.

In the 2014-15 academic year, New Hope Tutorials offered 26 full-year courses to a total of 123 students from 88 families in 18 subjects. 23 of our students graduated this year, most of them going on to attend four-year colleges. New Hope Tutorials also provided "short courses" in writing, math and art, as well as a variety of other enrichment workshops running 6-12 weeks.
