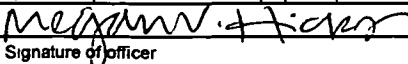
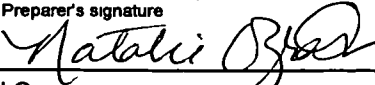

Tobacco-use Prevention The SCTFC approaches tobacco-use prevention through a comprehensive control methodology, commonly referred to as "best practice". For the current year, the SCTC accomplished the following in pursuit of this methodology: 1) Fielded an estimated 200 phone calls from citizens interested in tobacco cessation services, referred those callers to the state's Tobacco Quitline (800-QUIT-NOW); 2) Advised over 2,600 database members on regional tobacco-use prevention activities across South Carolina; 3) Provided technical and programmatic assistance to 25 community coalitions; 4) Provided educational services to municipal leadership as requested by city/town/county managers or executives; and 5) Held seven regional sessions to gather input on state plan development. The goal of this program is to reduce tobacco-use prevalence and dependence in South Carolina. The objective is to reduce smoking rates by 1% per program year for 10 years, or for another period of time as determined by interested stakeholders.

Support Healthy South Carolina Initiative - The organization supports the Healthy South Carolina Initiative's efforts that maximize health impact through prevention, advance health equity, eliminate health disparities and expand the evidence base for local policy and environmental and infrastructure changes that impact health. These efforts are aimed at reducing death and disability due to tobacco use by 5 percent, reducing the rate of obesity through nutrition and physical activity intervention by 5 percent and reducing death and disability due to heart disease and stroke by 5 percent. As a partner in these efforts, SCTFC leads the Tobacco-Free Living strategy section of the Community Transformation Grant implementation plan. The SCTFC 1) Participated in sustainability workshops for grantees, and 2) Continued contractual relationships with 2 organizations to increase reach into SC's rural communities.

American Nonsmokers' Rights Foundation These funds represented funding for a two component project aimed at 1) the education on the dangers of secondhand smoke exposure and the benefits of smoke-free environments and 2) collecting experiential data from communities that are already smoke-free. The first component was locally based and focused on education in two target communities, Greenville County and Orangeburg County. The second component concentrated on data collection and material development. The data collected related to compliance and economic impact of existing smoke-free laws in SC. The materials developed are being used at both the local and state level to inform decision makers about smoke-free policy.
